Mindful of the interests and endeavors of business in the two countries, the chambers (hereinafter referred to as the two parties), agree to strengthen the links between the organizations and to further promote trade, industrial, economic and technical co-operation between their members.

In order to achieve the above aims, they reached the following agreement:

Article 1

Encourage and promote direct contacts between entrepreneurs in the Republic of Croatia and the Hashemite Kingdom of Jordan so as to strengthen the development of commercial and industrial activities between them.

Article 2

Facilitate and promote the exchange of business delegations, examine economic/industrial co-operation between the companies of the two countries and expand economic, trade, investment, technical and scientific co-operation between two countries.

Article 3

The two parties shall be committed to the periodical exchange of their economic trade and law information. The specific enforcement of which should be subject to the deliberation between the organizations.

Article 4

The two parties shall within their own authority provide the necessary facilities for business activities of the other party within their respective territories, so as to efficiently strengthen the economic co-operation and encourage trade contacts between the organizations and their member's enterprises.

Article 5

Assist in establishing contacts in connection with trade fairs and exhibitions, technical or economic symposia and other means of trade promotion including the exchange of information on the economy and foreign trade.

Article 6

Examine the possibilities for co-operation in country markets and to keep each other better informed concerning projects in this respect, all organizations should exchange information aimed at identifying specific.

Article7

Utilize visits by members or officials from the organizations to discuss matters of mutual interest.

Article 8

The two parties shall Co-operate in the fields of trade and maritime arbitration, patent application, as well as trademark registration. In particular, both parties are obliged to give assistance required for solving trade disputes that may arise in business transactions between their members amicably through reconciliation or through arbitration.

This agreement enters into force on the day of its signing and shall be valid until any of the organizations requests its termination in writing to other organization. All organizations have the right to propose any amendment they consider necessary to improve the co-operation between them.

This agreement is signed in Amman on the 21 March 2004.

PROTOCOL ON THE ESTABLISHMENT OF THE JORDANIAN-CROATIAN BUSINESS COUNCIL

The Jordan Chamber of Commerce, The Jordan Chamber of Industry and the Croatian Chamber of Economy, hereinafter referred to as the Contracting Parties,

Referring to the Agreement of Cooperation between the two Contracting Parties signed on 21st March 2004,

Striving to further promote the expansion of trade and economic cooperation between the Hashemite Kingdom of Jordan and Republic of Croatia,

Desiring to broaden the ties of partnership between the Jordanian and Croatlan business communities,

HAVE AGREED as follows:

Article 1

The contracting Parties set up the Jordanian – Croatian Business Council, hereinafter referred to as the Council, a non-governmental consultative body designed to render assistance in establishing direct business relations between the Jordanian and Croatian organizations, firms and entrepreneurs and implementing actions intended to develop trade and economic cooperation between the two countries.

Article 2

The Council shall promote the establishment of direct relations between Jordanian and Croatlan organizations, firms and entrepreneurs, render assistance in their practical activities and facilitate development of bilateral; trade, industrial, technological and investment cooperation.

Article 3

The Council shall promote regular exchange of economic, trade and business information and entrepreneurial experience in the activities in foreign markets.

Article 4

The Council shall undertake to help in the development of fair and exhibition activities, organizing economic, technical and investment seminars, symposia, conferences and other events aimed to expand bilateral; trade, economic and investment cooperation.

Article 5

The Council shall promote the exchange of information concerning particular projects and respective organizations that operate or have the information to operate in the Croatian and Jordanian markets, the creation and successful operation of joint ventures with the participation of the capital of the Parties residents or other mutually beneficial forms of cooperation.

The Council shall promote the coordination of effects with the purpose of realization of joint projects in the markets of the third countries and joint participation in other international projects.

Article 6

The Council is to be composed from 20 members, 10 members from each side, representing several sectors and economical activities. Honorary consuls for each country shall be a members in this council. Honorary Consul of Croatia in Jordan will be a member at the Jordanian side and the Honorary Consul of Jordan in Croatia will be a member at the Croatian side.

Article 7

The Council will meet once every year in either country, by turn.

Article 8

The council will approve in his first meeting the regulations which should be adapted to regulate the work of the council.

Article 9

Each side will elect the chairman, vice chairman, general secretary of his group.

Article 10

The meetings will be chaired by the chairman of the group of the country in which the meetings are held.

Article 11

This Protocol shall enter into force on the date of its signature and shall be of unlimited duration.

Article 12

This protocol may be terminated not earlier than three months after the date of a written notification by either party about the intention to cancel the Protocol.

This protocol has been signed in Zagreb on Thursday 26th; August 2004 in three original English copies each being equally authentic.
