AGREEMENT OF COOPERATION

The Argentine Arab Chamber of Commerce, the Jordan Chamber of Commerce, and the Jordan Chamber of Industry hereinafter referred to as the "Parties".

Considering the mutual aspirations towards the establishment of closer contacts between the entrepreneurs of the two countries.

Taking into account new opportunities to develop mutually beneficial trade and economic relations.

Desirous of taking the advantage of the new most efficient forms of cooperation in joint economic activities.

Have agreed as following:

Article 1

The parties shall take all the opportunities within their competence to promote, strengthen, and expand trade, economic, scientific, technological cooperation and other business relations between enterprises, entrepreneurs and organizations of Argentina and Jordan.

Article 2

The Parties shall exchange information of mutual interest on economy, foreign trade, trade rules and customs, as well as on amendments regarding trade legislation and other information materials.

Article 3

The Parties shall promote and expand mutually beneficial forms of cooperation between enterprises, firms, entrepreneurs as well as associations and amalgamations there of the Argentine Arab Chamber of Commerce, and the Jordan Chamber of Commerce and the Jordan Chamber of Industry.

Article 4

The Parties shall render assistance in organizing seminars, conferences, promote exchange of visit of business and technical specialists.

Article 5

The Parties shall render necessary assistance to enterprises, firms, entrepreneurs as well as their participation in international, national and specialized exhibitions, displays, fairs and other advertising and information events held both in the Argentine and Jordan.

Article 6

The Parties shall cooperate in rendering assistance to enterprises, firms and entrepreneurs as well as associations there of Argentine Arab Chamber of Commerce, Jordan Chamber of Commerce and Jordan Chamber of Industry on issues, which are related to arbitration.

Article 7

The Parties shall take necessary steps aimed at the implementation of this agreement.

Article 8

Representatives of the Parties shall meet alternatively in Argentine and Jordan for the purpose of working out measures necessary for the implementation of this Agreement.

Article 9

This Agreement shall come into effect on the date of its signing and shall remain valid until notice of its termination given in writing by either Party in which case the Agreement shall be terminated three months after the date of the said notice.

Signed in Buenos Aires, Argentina, on 27 October 2008, in three identical copies in English, all of them having equal validity.

MEMORANDUM OF UNDERSTANDING

Between the
Jordan Chamber of Industry
Jordan Chamber of Commerce
and the
Union Industrial Argentina

Taking into account the nature and the representativeness of the signing organizations in their own countries and the important role they both have in carrying forward their countries business interests;

Considering that further to this understanding and the countries' business communities wish to develop a closer relationship, it is desirable that the employers federations take actions with the objective of consolidating this process;

The Union Industrial Argentina (UIA), and the Jordan Chamber of Industry and the Jordan Chamber of Commerce hereby formulate the present Memorandum of Understanding:

1. This MEMORANDUM OF UNDERSTANDING has in view to promote the development of the signing countries' business communities and to increase the commercial and industrial relations between them.
2. The signing organizations agree to exchange information related to their acting field and which can contribute to foster businesses between the two countries.
3. The exchange of information referred to in the previous clause must be related to economic and commercial matters regarding the general and specific industrial sectors' interests of both countries.
4. The signing organizations shall likewise assist the companies regarding direct investments in Argentina and Argentinean companies as to direct investments in.
5. The Union Industrial Argentina (UIA), and the Jordan Chamber of Industry and the Jordan Chamber of Commerce agree to exchange professional experiences related to the services rendered to their respective members facilitating their relationship and specially providing adequate support to the Small and Medium Size Enterprises.
6. The two entrepreneurial organizations shall promote activities such as seminars, courses and conferences in both countries on subjects to be further agreed upon as well as to divulge those events through their respective publications.
7. This agreement can be modified by consensus of both partners and can be terminated on the initiative of either signatory party of the Memorandum of


Understanding with a prior written notice of at least three months.

8. This agreement shall enter into force on the date of its signature by a representative of each party.


