رحب العين حيدر مراد بالسادة الحضور مشيرا الى ان العلاقات بين البلدين الصديقين بدأت تشهد تطورا مهما منذ زيارة جلالة الملك عبد الله الثاتي حفظه الله الى جمهورية كاراخستان، والنتائج التي أسفرت عنها تلك الزيارة على كافة الأصعدة السياسية والاقتصادية، وإمكانيات زيادة حجم التبادل التجاري خاصة في مجال استيراد الحبوب والقمح من هذه الجمهورية الغنية بهذه المواد، وأوضح ان زيارة دولة رئيس الوزراء السابق الى هذه الجمهورية مع ممثلي الفعاليات الاقتصادية المختلفة قد أرست دعائم علاقات متينة في جميع المجالات في المستقبل، موضحا أن القطاع الخاص الأردني ممثلا بغرفة تجارة الأردن وغرفة صناعة الأردن قد بدأ بعد جسور التعاون مع هيئات القطاع الخاص في كازاخستان، والتي توجت بتوقيع اتفاقية إنشاء مجلس الأعمال الأردني الكازاخستاتي المشترك مع غرفة تجارة وصناعة استانا، وانعقاد الدورة الأولى لهذا المجلس في استانا في وقت سابق.

ودعا العين مراد الأصدقاء في كازاخستان الى التعرف على امكانات استيراد وتصدير البضائع والمواد المختلفة، وكذلك التعرف على واقع ومناخ الاستثمار وبينة الأعمال في الأردن وامكانات وفرص الاستثمار والتعاون مع نظرائهم الأردنيين في إقامة استثمارات ومشاريع مشتركة تستفيد من المميزات الكثيرة المتوافرة في المملكة في ظل ما تنعم به من الأمن والاستقرار ووجود البنية الأساسية والخدمات والإعفاءات والحوافز المالية والضريبية ووجود مناطق حرة وصناعية ومؤهلة، ووجود عدد من اتفاقيات التجارة الحرة مع أهم دول العالم.

من جانبه أكد الدكتور حاتم الحلواني على أهمية تطوير العلاقات بين الفعاليات الصناعية في البلدين خاصة في النواحي التكنولوجية والإنتاجية والتدريبية والمواصفات والمقاييس والتعاون في مجالي الترويج والتسويق المشترك وتبادل مدخلات الإنتاج الصناعية، مشددا على أهمية زيادة تبادل المنتجات الصناعية داعيا الى توثيق التعاون بين رجال الأعمال وممثلي القطاع الخاص في البلدين من خلال تفعيل دور مجلس الأعمال الأردني الكازاخستاني وعقد اجتماعات لهذا المجلس بشكل دوري لما لذلك من فرصة لتطوير العلاقات التجارية والاستثمارية بين البلدين.

من جهته أكد العديد يرلان كوزامدي، رئيس غرفة التجارة والصناعة في كار الحستان أنه على مدى ١٥ سنة من العلاقات الدبلوماسية بين كار الحستان والأردن، تم إرساء القواعد الملائمة للتجارة الثنائية والاستثمارات المتبادلة، إلا أن المستوى الحالي للتجارة بين البلدين لا يلبي الامكانات المتوافرة لدى البلدين، علما بأن الهدف الرئيسي لمجلس الأعمال المشترك هو تحسين هذا الوضع. واقترح ضرورة إنشاء موقع الكتروني لمجلس الأعمال المشترك الكار اخستاني الأردني. وهذا الموقع سيتضمن العروض التجارية والمشاريع الاستثمارية إضافة إلى مراجع قواعد البيانات والمعلومات مع المواقع الالكترونية المساعدة في كلا البلدين.

من جاتبه أعرب سعادة السيد بولات سارزنباييف السفير الكازاخستاتي في عمان أن زيارة الوفد الاقتصادي الكازاخستاتي سوف تشكل خطوة هامة نحو إقامة العلاقات بين الشركات ورجال الأعمال ومؤسسات القطاع الخاص في البلدين، وستتيح هذه الزيارة الفرصة أمام رجال الأعمال للتعرف على بعضهما وعلى الاقتصاد والمنتجات الأردنية على أرض الواقع إضافة إلى امكانات الاستيراد والتصدير. وأعرب السفير عن شكره لغرف التجارة والصناعة في الأردن على الخطوات الهامة التي اتخذوها لبناء العلاقات مع جمهورية كازاخستان.

## Second Minutes of Joint Business Council Meeting Between

## Jordan Chamber of Commerce Jordan Chamber of Industry

### Amman Tuesday 26/2/2008

The Kazakhstan – Jordanian Business Council held the second meeting in Amman on Tuesday 26/2/2008 under the chairmanship of Senator Haider Murad, Chairman of Jordan Chamber of Commerce, His Excellency Dr. Hatem Halawani, Chairman of Jordan Chamber of Industry and Mr. Yerlan Kozhasbay, President of Chamber of Commerce and Industry of the Republic of Kazakhstan along with a number of the private sector representatives on both sides.

Senator Haider Murad welcomed the esteemed attendees noting that the relationships between the two friendly countries started showing considerable improvement since the visit which His Majesty King Abdullah II, may God safeguard him, paid to the Republic of Kazakhstan. This visit yielded important results on all political and economic levels and in terms of prospects for increasing the volume of trade exchange especially in the field of importing cereals, wheat, and oil from this Republic, which is rich in such materials. Senator Murad pointed out that the former prime minister's visit to this republic accompanied by representatives of the different economic in situations laid down the grounds for solid future relations in all fields. He indicated that the Jordanian private sector, represented by both of the Jordan Chamber of Commerce and the Jordan Chamber of Industry, started building bridges of cooperation with the private sector institution in Kazakhstan, including an agreement signed for establishing the Joint Kazakhstan-Jordanian Business Council with the Chamber of Commerce and Industry of the Republic of Kazakhstan and the convening of the first session by this Council in Astana earlier.

Senator Murad called on the friends in Kazakhstan to find out the prospects for importing and exporting different goods and materials, and to explore the investment realities and climate, business environment in Jordan, investment opportunities and cooperation with their Jordanian counterparts in launching joint investments and projects. Such projects will benefit from the numerous advantages in the Kingdom such as security, stability, infrastructure facilities, services, exemptions financial and tax

incentives, free zones, Qualified Industrial Zones (QIZ), along with a number of free trade agreements with the major countries around the world.

On the other hand, Dr. Hatem Halawani, Chairman of the Jordan Chamber of Industry emphasized the importance of improving the relationships between the industrial institutions in the two countries, particularly in the fields of technology, production training, standards, measurements, along with cooperation related to joint promotion and marketing, and exchanging industrial outputs. Dr. Halawani stressed the importance of increasing the exchange of industrial products and called for the businessmen representatives in the two countries through activating the role of the Kazakhstan - Jordanian Business Council and holding regular meetings for this Council. This will provide an opportunity for improving the trade and investment relations between the two countries.

For his part, Mr. Yerlan Kozhasbay, President of Chamber of Commerce and Industry of the Republic of Kazakhstan stressed that for 15 years of diplomatic relations between Kazakhstan and Jordan the proper grounds for bilateral trade and mutual investments have been created. However, the current level of trade does not meet the potential, existing in both countries and the main goal of JBC is to improve the situation. He suggested that web-site of Kazakhstan-Jordanian JBC have to be created. This site will contain commercial offers and investment projects as well as references to informational databases, and helpful web-sites in both

H. E. Mr. Bulat Saresenbayev, the ambassador pointed out that the Kazakhstan economic delegation's visit will be an important step towards establishing relations between the companies, businessmen and private sector institutions in the two countries. This visit will also provide the businessmen with an opportunity to know each other and to explore the realities pertaining to the Jordanian economy and products along with export and import potentials. The ambassador expressed his thanks to the Chambers of Commerce and industry in Jordan for the important steps they have taken towards building relations with the Republic of Kazakhstan.

After reviewing the methods and fields of cooperation, investment, partnership, and trade exchange between the two friendly countries, the two sides reached the following agreement:

## First: In the field of bilateral trade

Discussing the means of increasing the volume of bilateral trade and the possibility of expanding Kazakhstan imports of Jordanian

products, particularly the medicines which enjoy an internationally distinguished position.

- Launching cooperation and coordination between the two sides so that the private sector will play a role in signing a free trade agreement between Jordan and Kazakhstan.
- Facilitating the goods transport operations between the two countries.

## Second: In the field of investment

- Conducting a serious discussion of the investment opportunities available in both countries, exploring the prevalent investment climate along with the incentives, opportunities, and potentials, and holding further meetings between the businessmen and investors of the two countries.
- Inviting the businessmen of Kazakhstan to benefit from the investment opportunities in Jordan, especially companies currently open for investment and privatization along with the projects in the Aqaba Special Economic Zone Area (ASEZA) and the economic development areas in Mafraq, Ma'an and Irbid.
- Calling on the official authorities of Kazakhstan to facilitate establishment of Jordanian investments in the field of pharmaceutical, contracting, and building industries, and to discuss possibilities for signing investment encouragement and protection and other agreements.

## Third: In the field of industry

- Discussing the prospects for industrial cooperation, adopting technology, exchanging information related to industrial goods and products, informing importers in both countries of such goods and products, and exploring the two markets, needs for those goods and services.
- Discussing information on the raw materials available for industry in both countries for benefiting from them in the manufacturing processes.
- Discussing the possibilities for participating in the international exhibitions specialized in the industrial products in the two countries.

## Fourth: Joint Council's role

Reaching agreement on periodical meetings to be held for the Joint Kazakhstan- Jordanian Business Council in both of Kazakhstan and Jordan in order to continue with the process of communication related to the different common issues, and consolidate links between the business communities, economic institution representatives, and investors in the two countries.

- Role played by the Council in organizing the trade and investment delegations visits and expanding the two sides, participation in the economic institutions, conferences, and exhibitions in the two countries.
- Emphasizing the Council's role in terms of introducing the investment opportunities and potentials in the two countries, exchanging information on the laws, trade movement, industrial production, and export and exchange bulletins and periodicals issued by the parties to the Council including the Chambers of Commerce and Industry.

# AGREEMENT ON THE ESTABLISHMENT OF JOINT BUSINESS COUNCIL (JBC) BETWEEN JORDAN CHAMBER OF COMMERCE AND JORDAN CHAMBER OF INDUSTRY AND

## CHAMBER OF COMMERCE & INDUSTRY OF THE REPUBLIC OF KAZAKHSTAN (CCI RK)

The business communities of the Hashemite Kingdom of Jordan and the Republic of Kazakhstan feel the need to establish a co-operative body on a private initiative to facilitate continuous interaction between them so as to increase trade and economic co-operation between the two friendly countries.

The Jordan Chamber of Commerce and Jordan Chamber of Industry from the Jordan side and the CCI RK from the Kazakhstan side have agreed to set up a joint business council (**JBC**) in order to carry out more systematically business promotional activities in trade, investment, technology transfer, services and other industrial sectors. The **JBC** will provide a regular and recognized forum for discussion on promotion of these activities between businessmen and industrialists of the two countries.

#### I. ORGANIZATION

- 1) The Jordan-Kazakhstan **JBC** meetings shall be organized in Jordan and Kazakhstan respectively for liaison and consultation between the business circles of the Hashemite Kingdom of Jordan and the Republic of Kazakhstan.
- 2) Either side, in general, shall be composed of businessmen of different economic interests. The number of committee members and the manner of operation are prescribed separately in each country.
- 3) While working in closest collaboration and cooperation, each side is autonomous in its own sphere.

#### II. AIMS OF JBC

The JBC aims at fostering friendship and understanding between the business communities of Jordan and Kazakhstan promoting cooperation in trade, investment, technology transfer, services and other industrial sectors between both countries.

#### III. ACTIVITIES OF JBC

The **JBC** (Both sides) shall conduct the following activities in order to achieve the aims stated in the preceding paragraphs.

- 1) Exchange of information shall be conducted in regard to trade, economic cooperation and services between the two countries.
- 2) Appropriate materials necessary for promoting close economic relations between the two countries may be submitted to the respective governments, if considered desirable by either side in that country.
- 3) Recommendations necessary for promoting close economic relations between the two countries may be submitted to the respective governments if considered desirable by either side in that country.
- 4) Encourage businessmen to participate in exhibitions held in the Hashemite Kingdom of Jordan and the Republic of Kazakhstan
- 5) There shall be cooperation between both sides in sponsoring missions and receiving businessmen and technical experts, when considered appropriate.
- 6) Other activities useful for achieving the purposes of the **JBC** shall be conducted.

#### IV. JOINT MEETING

- 1) Both sides shall hold joint meetings as mutually agreed upon on various problems pertaining to the promotion of trade, economic cooperation and service between the Hashemite Kingdom of Jordan and the Republic of Kazakhstan.
- 2) The joint meeting shall be held alternately in either country, once every year at least.

### V. ORGANISATION AND OPERATION OF JOINT MEETING

- 1) The joint meeting shall be co-chaired by a representative of each country.
- 2) Sub-committees and task forces may be appointed if necessary to consider and recommend on specific matters, in these cases.
- 3) The date, duration and agenda of the joint meeting and other particulars, deemed necessary shall be decided in advance by both sides as may be mutually agreed upon.

#### VI. EXPENSES FOR JOINT MEETING

Various expenses for making preparations and conducting the joint meeting shall be borne by the sponsoring side and the traveling expenses, hotel expenses, etc., of the representatives of the visiting side. In general, each side shall carry their own expenses.

#### VII. SECRETARIAT

Each side shall make arrangements for secretarial services best suited to its needs, while on the Jordanian side, the secretarial services and activities as meant in Article III (1), (2), (3), and (4) will be carried out by the Jordan Chamber of Commerce and Jordan Chamber of Industry, in the Republic of Kazakhstan these will be carried out by the CCI RK.

#### VIII. OTHER ARRANGEMENTS

Other organizations in both countries may subscribe to this **JBC** by submitting an application to this effect to both sides of this **JBC**.

Agreement shall enter into effect upon signature by both parties and can be terminated by either party after six months written notice.
